Policy Regarding Age Verification

WHEREAS, Tamiami Master Association, Inc. (hereinafter "Association") is the corporate entity charged with the operation, maintenance, and management of Tamiami Village: and

WHEREAS, the Park Rules and Conditions, Covenants, Changes, Restrictions and Reservations are intended to demonstrate that the Park is operated as a "55" and over" housing facility as that term defined in the Fair Housing Amendments Act of 1988, as amended by the Housing For Older Persons Act of 1995; and

WHEREAS 24 CFR / 100.307 (the Rules promulgated by the United States Department of Housing and Urban Development implementing the above-referenced laws) requires Association to develop procedures for routinely determining the occupancy of each unit, and for updating unit, and for updating unit occupancy information; and

WHEREAS the Association wishes to comply with said requirements, IT IS RESOLVED as follows:

- 1. The "FAIR HOUSING ACT CENSUS OCCUPANCY CHANGE FORM" attached to this Resolution shall be required to be completed whenever there is a change of occupancy of a unit, whether through sale lease, inheritance, or otherwise.
- 2. No later than December 31 of every odd numbered year (2005, 2007, 2009, etc.) Association shall update its population census by using the form attached hereto as "FAIR HOUSING ACT CENSUS UPDATE." The Association shall also obtain information, as changes in occupancy occur, contemporaneously with such changes.
- 3. The Board of Directors of the Association may adopt additional policies and procedures as may be necessary to effectuate the intent of the law and this Resolution.
